





# I would like to work, who can help me? Strenghtening cooperation between policy-makers and NGOs in the area of labour market integration of people with disabilities (RTW project)

#### Context

- Change in population structure and characteristics:
- ageing population across the EU including Slovakia
- chronic diseases on the rise (6 large groups: cardiovascular, cancer, musculoskeletal, mental, chronic respiratory, diabetes)
- policy relevance: how to keep populations health and active in the labour market (in the context of current labour shortages)
- Changes related to labour market participation and the character of work:
- low LM participation of people with disabilities (less than 17% compared to almost 67% of healthy population in Slovakia, data for 2015)
- digitalization's impact on the future of work these people are more vulnerable to be affected
- dual disadvantage ethnic minorities and homeless people, impact on their health, vulnerability for chronic diseases higher
- Policy relevance: how to assure longer labour market involvement (more efficient for the society)







#### Context

- Barriers to LM involvement of people with disabilities:
- Extent/scope of legislation to deal with LM integration of people with disabilities
- Obstacles with implementation of ALMPs to facilitate sustainable decent jobs for people with disabilities (e.g. hard to shift from temporary protected LM arrangements to the primary LM)
- Low awareness of people with disabilities about their LM/RTW opportunities, they often end up on disability pension whereas with some support and integration measures they could work (increase LM participation)
- Lack of interest representation of people with disabilities and therefore lack of access to supportive measures for their LM integration
- Lack of cooperation between various stakeholders (state, social partners, NGOs) in policy making and policy implementation







# **Project aims**

- Mapping the policy framework and policy implementation practice on LM integration of people with disabilities
- Collecting examples of good practice
- Evaluating the needs of people with disabilities at the labour market and position/capacities of relevant stakeholders to address these needs
- Formulate recommendations for changes in policy implementation practice
- Formulate recommendations with legislative impact (policy making, 3 legislative Acts)
- Facilitate interaction between various stakeholders in facilitating LM integration of people with disabilities








## **Concepts**

#### **Timeline**

Activity	Description	Time period
1. Analysing/mapping out legislative framework and existing labour market integration policies	Mapping out legislation, ALMPs and other integration policies in Slovakia and Norway targeting people with disabilities; desk research and data analysis.	June – Aug 2019
2. Data collection and data analysis (field research and case studies)	Mapping out key stakeholders in four categories of stakeholders, conducting interviews and two case studies (Roma & people who experienced homelessness). Outputs: (1) register of relevant orgs; (2) analysis of interviews; (3) two cases studies and benchmark study (Norway).	Sept 2019 – Feb 2020
3. Enhancing cooperation between relevant stakeholders	Organizing three roundtables in three regions (BA, BB, KE) for approx. 30 people from 4 categories of stakeholders	March – April 2020
4. Dissemination of findings	through websites of partner orgs, FB pages ,mass media. Outputs:(1) final study; (2) policy briefs; (3) podcast; (4) press release blog, commentary; (5) video.	April – Oct 2020
5. Preparation of the academic journal article	based on the bilateral Slovak-Norwegian cooperation, international journal (e.g, Journal of European Public Policy)	Sept – Oct 2020







# Methodology

- Definition of people with disabilities: a broader one, which includes not only people with a legal status, BUT ALSO those w/o a legal status still facing different barriers in the LM;
- Lifestyle, mental, cardiovascular, movement disorders/diseases etc.
- Intersectional and actor-oriented approach
- Case studies specific focus on two groups of people with disabilities
   (1) Roma men and women; (2) men and women who experienced homelessness







# Data collection and data analysis

- **Desk research**: legislation and strategic materials, analysing secondary data (e.g. data from the Social Insurance Agency, LOs) and examining already existing ALMPs and other programmes/policies on labour market integration of people with disabilities
- 30 semi-structured interviews with representatives of four categories of stakeholders (1) trade unions; (2) employers; (3) public sector; (4) NGOs;
- Two case studies (1) integration of Roma men and women; (2) men and women who experienced homelessness
- Norwegian case study/benchmark study: based on already existing research findings and expertise; focus on good practice examples and policy recommendations for particular stakeholders;
- Roundtables: both dissemination activity and data collection (+validation of findings)

- Key role in fieldwork focused on two groups with multiple disadvantages (ethnicity, poverty, living conditions in combination with poor health status): Roma and homeless people
- Comparative background report, final study, policy briefs, draft academic paper
- Blogs, video, podcast supporting CELSI in dissemination and PR

- Feedback on intermediary outputs

## Open questions/discussion

- Research perspective:
- Do we need a detailed analytical framework?
- Synergies with CELSI's REWIR project to what extent we can integrate the REWIR data into the RTW project (survey among social partners, interviews with medical organizations, NGOs, labour market authorities, government reprentatives, company-level workers' survey on RTW, two roundtables with representatives of companies and trade unions)
- Analysis of administrative data and big data for Slovakia (Lucia MK, LK), analysis of google searches of people aiming at RTW to learn what kind of information they are looking for and to use this for recommendations for particular types of stakeholders (CELSI)
- Division of work between CELSI and SGI on tasks where both partners participate
