- ☐ Employees carrying out simple tasks: meals preparation (16,3%).



# Main legislation/regulations related to PHS in Poland. Ministry of Family and Social Policy



- **System of support for informal caregivers of dependent elderly by public institutions.** 
  - 1. professional support for families providing home care counseling, consultation, skills training for informal caregivers (provided by doctors, nurses, physiotherapists, medical caregivers and social workers) and other activities to improve the quality of home care;
  - 2. introduction of various forms of periodic relief for family members providing personal care for dependent elderly;
  - 3. the creation of a **system of training and qualification** to obtain competencies to care for dependent elderly people, **including those aimed at professionals providing care services**;
  - 4. strengthening the network of informal caregivers of dependent elderly people.

#### Ministry of Health

"On December 27, 2021. The Council of Ministers adopted by resolution the strategic document entitled Healthy Future. Strategic Framework for the Development of the Health Care System for 2021-2027, with an Outlook to 2030.

- (...) Annex No. 1 to the document defines the Strategy for deinstitutionalization of health care: the elderly. The overarching goal of the Strategy in the section dedicated to the elderly is to:
- Improve health and health-related quality of life in older people and their caregivers;
- Supporting them to maintain their independence enabling them to function in the community for as long as possible.

Activities in the aforementioned area are primarily focused on:

- development of community-based forms of long-term care, palliative and hospice care, and care for people with dementia and other brain diseases resulting in memory impairment (including Alzheimer's disease);
- \* expanding health support for informal caregivers of the elderly in need of support in daily functioning."

#### Ministry of Health

"The following scopes of action are envisaged for the development of community health care for the elderly and support for their caregivers:


- Development of human resources by improving the competence of care staff (medical caregivers) in caring for the elderly in need of support in daily functioning to support long-term care and palliative and hospice care provided in the home setting;
- ❖ Development of forms of day care by expanding forms of medical day care, including for people with dementia disorders,
- ❖ Development of forms of home care by including medical staff (medical caregivers) trained in this field in the staff providing guaranteed services in the field of long-term care and palliative and hospice care provided in a home setting;
- Development of innovative forms of care through the dissemination of telemedicine services dedicated to the elderly and other people in need of support in daily functioning, and their inclusion in the scope of guaranteed benefits;
- ❖ Support for informal caregivers through activities of an informative nature (in terms of available forms of support and assistance with daily care), educational (in terms of proper care of the patient at home) and psychological support (available in the local environment and in remote form);
- ❖ Coordination of community care by providing a comprehensive database of information on publicly available forms of health care for the elderly and health support for their informal caregivers."

### **Precarity gaps**

(Grimshaw et al. 2016,

Jaehrling and Weinkopf 2016)

observed in Poland:

- Employment protection gaps
- Representation gaps
- Enforcement gaps
- Social protection and integration gaps





### PHS in Poland: the challenges

- Employment in the PHS sector in Poland usually remains unofficial/unregistered, despite the fact that some services are embedded in health care and social care systems.
- This makes it difficult to define and then enforce the rights and obligations of employers and employees (especially foreign workers), thus limiting protection against abuse, lowering occupational health and safety as well as the quality of services.
- > Gross salary oscillates around the national minimum.
- > Services require **professionalisation**.
- > Social dialogue should be promoted due to low state intervention and low formalisation in the PHS sector.
