We warmly invite you to join us for the presentation and discussion of a new comparative report on collective bargaining in the care sector in Central and Eastern Europe, produced within the international research project CEECAW: Challenges for Organising and Collective Bargaining in Care, Administration and Waste Collection Sectors in Central and Eastern European Countries.

The report analyses the **state of employment and social dialogue in the care sector** across 12 countries: **Bulgaria, Croatia, Czechia, Estonia, Hungary, Latvia, Lithuania, Poland, Romania, Serbia, Slovakia, and Slovenia**.

The care sector (covering long-term care, early childhood education and care, and social assistance services) is vital to public well-being. However, a recent 2024 research shows that this essential sector remains underfunded, fragmented, and undervalued, facing labour shortages, ageing staff, poor working conditions, and weak collective bargaining.

Join us to discuss the **findings from across the region**, their implications for future policy and practice, and exchange experiences and strategies for **reinvigorating organising and bargaining** in care.
